- Similar collections exist at other libraries all over the world.

  - Government-Sponsored Research into UAP & NHI.

#### **Unverifiable Experiencer Reports**

- Science Fiction author Whitley Strieber published the book Communion in 1987.
- Received letters from people making comparable allegations of interactions with Nonhuman Intelligence (NHI).
- Archives contain these letters and follow-up materials, such as interviews and correspondence.

#### Clinical Cases of UAP & NHI Experiencers

- John Mack, M.D. was Chair of the Psychiatry Department at Harvard Medical School.
- Clinical cases and research related to persons who alleged experiences with nonhuman intelligence.
  - Some data is restricted for privacy reasons.



#### UAP in Popular Culture

- Brenda Denzler, Ph.D. authored The Lure of the Edge: Scientific Passions, Religious Beliefs, and the Pursuit of UFOs (1998).
- UAP narratives are utilized to deconstruct and reconstruct both scientific and religious worldviews.



### UAP Experiencers, Historical Reports, & Government Involvement

- Jacques Vallee, M.S., Ph.D. worked on American
- government-sponsored research programs that examined UAP.
  - Collects UAP and NHI experiencer reports dating back hundreds of years.
  - Archival Collection unavailable until 2028.



#### Legal Cases Seeking American Government Disclosure

- Larry W. Bryant wrote UFO Politics at the White House: Citizens Rally 'round Jimmy Carter's Promise (2002).
- Filed multiple lawsuits against many different American government officials and federal departments seeking disclosure of information about UAP and NHI.
- Received thousands of pages of declassified documents through Freedom of Information Act requests.
- Largely still unorganized (I tried). Woodson Research Center needs funding to provide better organized data to researchers.



### Parapsychological Intelligence Gathering

- Edwin C. May, Ph.D. served as the second research director for the American Intelligence Community's Cognitive Sciences Program, which pioneered the use of psi for national security operations 1972-1995.
- Operational personnel utilized remote viewing, telepathy, and mind-machine interface techniques to gather information about UAP and NHI.
- These methods are discussed in the 2012 Kona Blue Proposed Special Access Program documents, which were released by the U.S. Department of Defense in 2024.



### Parapsychological Intelligence Gathering

- Ingo Swann was the co-founder and first intelligence operative to take part in the U.S. Cognitive Sciences Program.
- His papers are at the University of West Georgia Special Collections in Carrollton, Georgia.
- There are memos, raw notes, and correspondence that discuss his participation in American governmentsponsored programs that used parapsychological methods to gain information about UAP and NHI.



### We Must Organize the Data

- Researchers can distinguish between unverifiable allegations and government-sponsored research.
- Relevant archival evidence is available, but it is often held only as physical copies in disparate locations.
- Collections are often unavailable for digital search.
- We need to build a database of relevant archival documents to inform policy conversations.
